<p><b>2a INTERMENTS OF ASHES IN AN EXISTING GRAVE PLOT ONLY</b>            Stillborn babies, babies and children under 12 years will incur a NIL charge.</p> <ul style="list-style-type: none"> <li>• A person whose age at the time of death exceeded 12 years.</li> </ul>	<p>50.00</p>
<p><b>3 MONUMENTS, GRAVESTONES AND MONUMENTAL INSCRIPTIONS</b></p> <p>For the right to erect or place on grave category (1a):</p> <ul style="list-style-type: none"> <li>• A headstone not exceeding 2' 6" in height</li> <li>• A footstone not exceeding 2' in height (sections A, B &amp; C only)</li> <li>• Kerbstones or border stones enclosing a space (sections A, B &amp; C only):               <ul style="list-style-type: none"> <li>- not exceeding 7 feet by 3 feet</li> <li>- enclosing an area in excess of 7 feet by 3 feet, <u>each</u> space of 7 feet by 3 feet</li> </ul> </li> <li>• <b>IN THE EVENT OF A SINGLE MONUMENT SPANNING TWO GRAVE SPACES, THE FOOTSTONE MUST SPAN BOTH BURIAL PLOTS AND BE A MINIMUM OF SIX FEET WIDE.</b></li> <li>• A monument in the form of a vase.</li> <li>• A monument in any other form.</li> </ul>	<p>75.00</p> <p>25.00</p> <p>35.00</p> <p>25.00</p> <p>75.00</p>

#### NOTES

The foregoing fees, payments and sums will be doubled where the person to be interred or in respect of whom the right is granted is, or was, immediately before death, not an inhabitant or parishioner of Deeping St James, or in the case of a still-born child, neither of the parents is, or was at the time of interment an inhabitant of Deeping St James, unless evidence can be produced to the satisfaction of the Clerk that such person had been a habitant or parishioner during the immediately preceding ten years.
